Weddings are a compilation of specific details that, when strung together, make up one of the most magical days of your life. The professional and experienced staff at Via would be honored to play an essential role in one of the most important details: camera-ready perfection.

Our Bridal hair services include a trial (required for bride only, if including makeup there is a separate trial required for makeup) and an in-depth consultation to discuss various options for your big day. This trial appointment is to ensure perfection as well as to determine the amount of time that will be needed on the day of the wedding. The trial consists of a two-hour appointment with the opportunity to discuss and try multiple styles (if necessary). If additional time is needed, another appointment will have to be made for a second trial and an additional fee will be charged at the stylist's discretion. Perfect bridal hair is only half of the equation to achieving wedding day perfection, and with that being said, we also offer Makeup services to complete your wedding day look. We highly recommend booking these trial appointments together, so our stylists are able to better collaborate on your final style!

TIPPING IS NOT INCLUDED IN PRICING. 20% GRATUITY WILL BE ADDED TO EACH SERVICE FOR PARTIES OF 6 OR MORE.

STYLE TIP: For both the day of the trial and the wedding day, we suggest that you do NOT shampoo or flat iron your hair the day of your appointment. We also ask that your hair be fully blown dry both days of your appointments and prefer that it be washed the night before (slept on one night). Please pass this info on to everyone who will be receiving services on the wedding day.

DEPOSIT: A deposit is required to reserve our stylists for services. Once VIA has created your quote, ½ of that will be required to reserve your date, and the other ½ will be collected 7 days prior to your wedding date. Our stylists want our energy and attention to be focused on hair and makeup and will not be collecting payment on the day of.

CANCELLATION POLICY: You must cancel 90 days prior to your event in order to receive a full refund.

LATE POLICY: If a person in your party arrives 20 minutes or more later than their scheduled time, it may result in the inability to be serviced. In this case, you will still be expected to pay in full. This applies for both the trial run and the wedding day. We understand that there are always complications surrounding your big day. However, it is imperative that your bridal party be on time for their scheduled appointments so that we may provide you with our full attention. We want your experience to be smooth and enjoyable, but please remember that we work on a fixed time schedule with various other appointments booked throughout the day. If additional people would like services after this contract is completed, please contact the salon immediately so that we can update and plan accordingly. Please be advised that this may alter the amount of time needed as well as your schedule.

Additionally, our stylists may be booked with other appointments or bridal parties that day, and there is a chance that **any add-ons may not be accommodated.**
